**STIPULATION AND ORDER FOR
RETURN OF PROPERTY**


19 **WHEREAS** on August 7, 2008, the Mendocino County Sheriff's Office arrested
20 Defendants and seized from them 160 hash patties. Each patty weighed
21 approximately 27 grams. On July 24, 2009, the criminal charges against the
22 Defendants were dismissed. Defendants have moved this Court for an Order
23 directing the Sheriff to return to them the above-described hash patties. At the time of
24 the seizure, Defendants claim they had a total of four medical marijuana
25 recommendations. As of the date of seizure, the amount a medicinal marijuana user
26 could possess in Mendocino County was eight ounces of marijuana. (See MCC
27 9.37.040)
