**AN ORDINANCE OF THE SACRAMENTO COUNTY ZONING CODE  
PROHIBITING ANY USES INCONSISTENT WITH BOTH  
STATE AND FEDERAL LAW**

The Board of Supervisors of the County of Sacramento, State of California,  
ordains as follows:

WHEREAS, there may be inconsistencies between both State and Federal law  
regarding land uses;

WHEREAS, the County of Sacramento desires to determine what types of land  
uses are permitted, conditionally permitted or prohibited within its boundaries; and

WHEREAS, in order to protect the health, safety and welfare of the community,  
the County of Sacramento desires to add a provision to the Zoning Code which prohibits  
uses inconsistent with State or Federal law.

NOW, THEREFORE, THE BOARD OF SUPERVISORS ORDAINS AS  
FOLLOWS:

**SECTION 1.** Section 101-14 is added to Title 1 of the Zoning Code to read as  
follows:

**101-14 Consistency with State and Federal Law**

Notwithstanding any other provision of the Zoning Code, any land use, activity or  
establishment that contravenes either state or federal law, or both, is prohibited.

**SECTION 2.** This ordinance shall take effect and be in full force on and after  
thirty (30) days from the date of its passage, and before the expiration of fifteen (15)  
days from the date of its passage it shall be published once with the names of the  
members of the Board of Supervisors voting for and against the same, said publication

to be made in a newspaper of general circulation published in the County of Sacramento.

On a motion by Supervisor Peters, seconded by Supervisor Yee, the foregoing ordinance was passed and adopted by the Board of Supervisors of the County of Sacramento, State of California, this 6th day of December 2011, by the following vote:

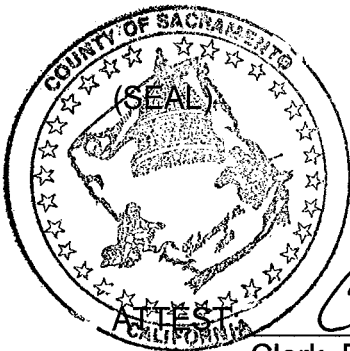

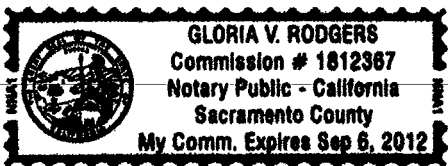
