Dear Mr. Figueroa:

I am in receipt of your letter to the San Mateo County District Attorney's Office, in which you requested documents pursuant to the Public Records Act. I represent the Office of the San Mateo County District Attorney and I write this letter on its behalf in response to your request. Your request is as follows:

Any and all documents or information concerning medical marijuana, Proposition 215 (codified as Health and Safety Code § 11362.5) and/or Senate Bill 420 (codified as Health and Safety Code §§ 11362.7-11362.83), including, but not limited to, any and all guidelines, bulletins, orders, directives, policies, and/or protocols. Please provide any and all documents or information concerning medical marijuana doctors, patients, caregivers, dispensaries, collectives, cooperatives and/or associations.

Your request is vague, overly broad and lacks the specificity required to allow my client to identify relevant documents and separate them from documents protected by privilege or privacy rights. As a result, the District Attorney's Office cannot provide a response without further clarification as to what you are seeking. However, in a good faith effort to provide you with documentation that might be within the realm of documents you seek, I have enclosed a copy of the County's Ordinance on Regulation of Collective Cultivation and Distribution of Medical Marijuana.

Please direct any further follow up or clarification of your request directly to me.
